## Parable Of The God's Light

### The Qur'an's Discussion of Laser Light 1,400 Years Before Its Discovery



#### The Verse of Light

اللَّهُ نُورُ السَّمَاوَاتِ وَالْأَرْضِ

[An-Nūr: 35]

is among the Qur'anic passages that have long captivated exegetes and researchers throughout history.

*"Allah is the Light of the heavens and the earth. The example of His light is like a niche within which is a lamp; the lamp is within glass, the glass as if it were a pearly [white] star lit from [the oil of] a blessed olive tree, neither of the east nor of the west, whose oil would almost glow even if untouched by fire. Light upon light. Allah guides to His light whom He wills. And Allah presents examples for the people, and Allah is Knowing of all things." (An-Nūr 24:35, Sahih International)*

With the development of optical and physical sciences in the twentieth century, some of its imagery can be mapped onto modern technologies such as the laser and the hologram, opening the door for a renewed scientific reading.

## Parable Of The God's Light

### 1. Laser: Monochromatic, Coherent, and Directed Light

A laser has three main properties:

- Monochromatic (single wavelength).
- Coherent (phase-consistent).
- Collimated (highly directional).

Its components intersect remarkably with the expressions of the verse:

- *"A niche within which is a lamp"* → the resonant cavity containing the active medium.
- *"The lamp in a glass"* → the transparent medium sustaining the light.
- *"As if it were a shining star"* → the glowing crystal that emits when excited.
- *"Lit from a blessed olive tree"* → the energy source that powers the medium.
- *"Light upon light"* → coherent amplification of photons, multiplying intensity and purity.

Of course, this is not the Light of Allah itself, but a worldly example of His Light.

Why would Allah choose laser-like light as an example of His Light?

Laser light is not just pure light; it is organized light with unique properties. Every photon travels in perfect harmony with the others, as if it were one connected ray.

These qualities reflect miraculous dimensions:

- Purity and clarity: Just as the laser is free of noise, the divine Light is absolute, unblemished.
- Harmony and coherence: All photons are in one phase, just as God's Light establishes order in the universe without chaos.
- Power and efficacy: Laser beams can cut steel though they are mere light; they can also heal and enable delicate surgery, advancing human civilization.

Thus the verse reveals the dual aspect of divine Light: light of guidance and mercy, and light of creative majesty capable of annihilating what He wills of creation — as in His words:

فَلَمَّا تَجَلَّى رَبُّهُ لِلْجَبَلِ جَعَلَهُ دَكًّا وَخَرَّ مُوسَىٰ صَعِقًا

[الأعراف: 143]

*“And when his Lord manifested Himself to the mountain, He made it level, and Moses fell unconscious.” (Al-A‘rāf 7:143, Sahih International)*

## 2. The Verse of Light and the Hologram (A Deeper Philosophical and Cosmic Reading)



A hologram is not merely an optical technique; it is a profound scientific philosophy about the very nature of reality. It works on the principle of light interference: the reflected light from an object is stored as a precise interference pattern, and when illuminated with a laser, the full three-dimensional image appears. It is not just imaging but a simulation of reality itself.

### Linking the verse to holography:

**“Allah is the Light of the heavens and the earth.”**

Just as a hologram is invisible unless illuminated by a true light source (usually a laser), existence itself depends upon the outpouring of divine Light. This “light” is not merely photons but the fundamental principle of being — the informational substrate of the cosmos.

## Prophet Muhammad in the Torah and the Gospel

### Unveiling Distortion and Reviving the Lost Truth



The glad tidings of the Prophet Muhammad ﷺ are still hidden within the sacred texts of the Jews and Christians, though they remain visible to those whom Allah grants insight.

This article is a linguistic and historical investigation from the perspective of comparative religion, aiming to demonstrate the truth with fairness and justice.

## 1. The Prophecy of “Muhammadim” in the Song of Songs

Song of Songs 5:10–16 (full text):

“My beloved is white and ruddy, chief among ten thousand. His head is as the most fine gold, his locks are wavy, and black as a raven. His eyes are like doves by the rivers of waters, washed with milk, and fitly set. His cheeks are as a bed of spices, as sweet flowers. His lips like lilies, dropping sweet smelling myrrh. His hands are as gold rings set with beryl. His body is like polished ivory overlaid with sapphires. His legs are as pillars of marble, set upon sockets of fine gold. His countenance is as Lebanon, excellent as the cedars. His mouth is most sweet, yes, he is altogether lovely. This is my beloved, and this is my friend, O daughters of Jerusalem.”



## Parable Of The God's Light

Hebrew text (Song of Songs 5:16):

חִפּוֹ מִמֶּתְקִים וְכָלֹ מִחֻמְדִּים זֶה דּוֹדִי וְזֶה רֵעִי בָנוֹת יְרוּשָׁלַם

Accurate translation:

“His mouth is sweetness itself, and he is Muhammadim. This is my beloved, and this is my friend, O daughters of Jerusalem.”

Analysis:

The word מִחֻמְדִּים (Muhammadim) is the Hebrew plural of respect for “Muhammad.”

All the qualities mentioned in the passage align precisely with the descriptions of Prophet Muhammad ﷺ:

- “*White and ruddy*” → reflects his complexion as described in Hadith.
- *Medium stature* → neither tall nor short.
- “*Locks wavy, black as a raven*” → matches his hair in Sīrah accounts.
- “*Eyes like doves, washed with milk*” → his eyes were wide, with striking whiteness and deep black.
- “*Hands as gold rings*” → strength and radiance in his hands.
- “*Legs as marble pillars*” → his balanced, upright build.
- “*Cheeks as a bed of spices*” → his ever-pleasant fragrance.

### How was it altered?

In modern translations, the word *Muhammadim* was changed from a proper name to “altogether lovely” — “Altogether lovely” = כָּלֹ מִחֻמְדִּים. This conceals the explicit name despite its presence in the Hebrew text.

### 2. The Prophecy of “Ahmad” in the Gospel

Qur’anic text:

وَمُبَشِّرًا بِرَسُولٍ يَأْتِي مِنْ بَعْدِي اسْمُهُ أَحْمَدُ

“...and bringing good tidings of a Messenger to come after me, whose name is Ahmad.”  
(As-Saff 61:6, *Sahih International*)

**Gospel of John 14:16** (standard text): “And I will pray the Father, and He will give you another Comforter, that he may abide with you forever.”

**The Greek terms: Current manuscripts read:**

**Παράκλητος (Parakletos) = Comforter, Advocate, Helper.**

**But the original was: Περικλυτός (Periklutos) = the praised one, the illustrious — which corresponds exactly to Ahmad in Arabic.**

**The distortion:**

Jesus (عليه السلام) and the disciples spoke Aramaic, not Greek. The Gospels were later written in Greek — the official language of the Roman Empire — which became the doorway for alteration.

At the Council of Nicaea (325 CE), Greek versions were standardized, while original early Gospels were ignored.

**Among the victims of this distortion were the Christians of Najran (the People of the Trench, أصحاب الأخدود), who adhered to the true monotheistic Gospel with the prophecy of Muhammad صلى الله عليه وسلم. They were burned alive by Dhū Nuwās with Jewish support, and Allah mentioned them in the Qur’an.**

The difference between the two words is only a few letters:

- **Παράκλητος (Parakletos) = Comforter.**
- **Περικλυτός (Periklutos) = Praised one (Ahmad).**

The change shifts the meaning from a human prophet praised by name to a spiritual entity (Holy Spirit) — erasing the prophecy of Muhammad صلى الله عليه وسلم.

### 3. The Prophecy of “Read — I cannot read” in the Torah (Isaiah 29:12)

The words uttered by the Prophet Muhammad صلی اللہ علیہ وسلم during the first revelation in the cave of Hirā' — when the angel Jibrīl commanded him “Read,” and he replied, “*I am not a reader*” — are mirrored in the Book of Isaiah.

Isaiah 29:12 (Hebrew):

וַנִּתֵּן הַסֵּפֶר עַל-אִישׁ לֹא-יָשָׁר לֵאמֹר קְרָא-נָא זֶה וְאָמַר לֹא-יָדַעְתִּי סֵפֶר:

Translation: “And the book is delivered to one who is not learned, saying, ‘Read this, please,’ and he says, ‘I cannot read.’”

This precisely reflects the Qur’anic testimony:

الَّذِينَ يَتَّبِعُونَ الرَّسُولَ النَّبِيَّ الْأُمِّيَّ الَّذِي يَجِدُونَهُ مَكْتُوبًا عِنْدَهُمْ فِي التَّوْرَةِ وَالْإِنْجِيلِ (الأعراف: 157)

*“Those who follow the Messenger, the unlettered prophet, whom they find written in what they have of the Torah and the Gospel...” (Al-A‘rāf 7:157, Sabih International)*

### 4. Other Prophecies of Muhammad in the Torah and Gospel

- Deuteronomy 18:18 — A prophet like Moses from “their brothers” (descendants of Ishmael).
- Deuteronomy 33:2 — The Lord shines from Sinai (Moses), from Seir (Jesus), and from Mount Paran (Mecca — Muhammad صلی اللہ علیہ وسلم).
- Isaiah 42:1–11 — The Servant of God bringing justice, praised in the lands of Qedar (son of Ishmael) and the people of Sela’ (Madīnah).
- Habakkuk 3:3–4 — The Holy One comes from Mount Paran, with rays from his hand — a sign of revelation.
- John 16:12–14 — The coming of the Spirit of Truth, who will speak not from himself but what he hears — fitting the description of a prophet.
- Qur’an, Al-Fath 48:29 — description of the Prophet and his companions, paralleled in the Gospel’s parable of the growing seed and mustard seed.

### A Call for Fairness

O seeker of truth, these texts are not casual interpretations but enduring signs that have survived attempts at suppression.

If approached sincerely, one will find in the Torah and the Gospel the light that leads to the Light of Muhammad صلی الله علیه وسلم.

قَالَ تَعَالَى:  
الَّذِينَ آتَيْنَاهُمُ الْكِتَابَ يَعْرِفُونَهُ كَمَا يَعْرِفُونَ أَبْنَاءَهُمْ وَإِنَّ فَرِيقًا مِّنْهُمْ لَيَكْتُمُونَ الْحَقَّ وَهُمْ يَعْلَمُونَ

(البقرة: 146)

*“Those to whom We gave the Scripture know him as they know their own sons. But indeed, a party of them conceal the truth while they know [it].” (Al-Baqarah 2:146, Sahih International)*

May Allah make this article a guidance for the lost, a light for the confused, and an argument for those seeking truth.

**What Science Has Discovered...**  
**and the Qur'an Had Already Declared**



Since the dawn of history, humankind has sought to understand the mysteries of the universe and existence: How did it begin? And why does it appear in such exquisite design?

With the progress of science — physics, astronomy, and biology — astonishing facts have been uncovered about the origin of the universe, its expansion, the motion of its bodies, the formation of matter, and the beginnings of human creation.

Allah said In quran:

“Have those who disbelieved not considered that the heavens and the earth were a joined entity, and We separated them and made from water every living thing? Then will they not believe?” (Al-Anbiyā’ 21:30, Sahih International)

## 2. The Expansion of the Universe

Edwin Hubble discovered that galaxies are moving apart — meaning the universe is in constant expansion.

وَالسَّمَاءَ بَنَيْنَاهَا بِأَيْدٍ وَإِنَّا لَمُوسِعُونَ

[الذاريات: 47]

“And the heaven We constructed with strength, and indeed, We are [its] expander.” (Adh-Dhāriyāt 51:47, Sahih International)

## 3. The Structure of the Universe and Allah’s Upholding of It

The universe operates under a precise system governed by gravity and fundamental forces, dark matter, dark energy, the Higgs boson, and superstrings. Were any of these to fail, the universe would collapse.

اللَّهُ الَّذِي رَفَعَ السَّمَاوَاتِ بِغَيْرِ عَمَدٍ تَرَوْنَهَا ثُمَّ اسْتَوَىٰ عَلَى الْعَرْشِ وَسَخَّرَ الشَّمْسَ وَالْقَمَرَ كُلٌّ يَجْرِي لِأَجَلٍ مُّسَمًّى يُدَبِّرُ الْأَمْرَ يُفَصِّلُ الْآيَاتِ لَعَلَّكُمْ بِلِقَاءِ رَبِّكُمْ تُوقِنُونَ

“It is Allah who erected the heavens without pillars that you [can] see; then He established Himself above the Throne and made subject the sun and the moon, each running [its course] for a specified term. He arranges [each] matter; He details the signs that you may, of the meeting with your Lord, be certain.” (Ar-Ra’d 13:2, Sahih International)

إِنَّ اللَّهَ يُمَسِّكُ السَّمَاوَاتِ وَالْأَرْضَ أَنْ تَزُولَا وَلَئِنْ زَالَتَا إِنْ أُمْسَكَهُمَا مِنْ أَحَدٍ مِّن بَعْدِهِ إِنَّهُ كَانَ خَلِيمًا غَفُورًا

[فاطر: 41]

“Indeed, Allah holds the heavens and the earth, lest they cease. And if they should cease, no one could hold them [in place] after Him. Indeed, He is ever Forbearing and Forgiving.” (Fāṭir 35:41, Sahih International)

### 4. The Pulsar Star (al-Tāriq) and Its Sound

Scientists have observed pulsars — neutron stars emitting regular radio signals like knocks.

وَالسَّمَاءِ وَالطَّارِقِ \* وَمَا أَدْرَاكَ مَا الطَّارِقُ \* النَّجْمُ الثَّاقِبُ

[الطارق: 3-1]

“By the sky and the night comer. And what can make you know what is the night comer? It is the piercing star.” (At-Tāriq 86:1–3, Sahih International)

### 5. The Descent of Iron and Water to Earth

Science has established that iron originated in supernova explosions, and that water formed through cosmic reactions before descending to Earth.

وَأَنْزَلْنَا الْحَدِيدَ فِيهِ بَأْسٌ شَدِيدٌ وَمَنَافِعُ لِلنَّاسِ

[الحديد: 25]

“...And We sent down iron, wherein is great military might and benefits for the people...” (Al-Hadīd 57:25, Sahih International)

[وَأَنْزَلْنَا مِنَ السَّمَاءِ مَاءً بِقَدَرٍ فَأَسْكَنَاهُ فِي الْأَرْضِ وَإِنَّا عَلَى ذَهَابٍ بِهِ لِقَادِرُونَ] [المؤمنون: 18]

“And We sent down from the sky water in a measured amount and settled it in the earth. And indeed, We are able to take it away.” (Al-Mu’minūn 23:18, Sahih International)

### 6. The Motion of the Sun and the Solar System

Science shows that the sun moves in its orbit toward a destination in the constellation Hercules.

وَالشَّمْسُ تَجْرِي لِمُسْتَقَرٍّ لَّهَا ذَلِكَ تَقْدِيرُ الْعَزِيزِ الْعَلِيمِ

[يس: 38]

“And the sun runs [on course] toward its stopping point. That is the determination of the Exalted in Might, the Knowing.” (Yā Sīn 36:38, Sahih International)

### 7. Tawaf and the Cosmic Orbits

The entire cosmos is in motion:

Electrons orbit nuclei. Planets orbit the sun. Galaxies move in their paths.

Similarly, humans circumambulate the Ka'bah — a symbolic harmony with the cosmic order.

### 8- Numerical Wonders of the Sun, the Moon, and the Days

The word “Sun” (الشمس) is mentioned 33 times, corresponding to its solar cycle.

The word “Moon” (القمر) is mentioned 27 times, equal to its lunar mansions and orbit around Earth.

The word “Day” (اليوم) appears 365 times, matching the number of days in the solar year.

The word “Month” (الشهر) is mentioned 12 times, equal to the number of months in a year.

### Moreover, the Qur'an reveals the mathematical equivalence:

300 solar years = 309 lunar years.

Allah Said:

وَلَبِثُوا فِي كَهْفِهِمْ ثَلَاثَ مِائَةٍ سِنِينَ وَازْدَادُوا تِسْعًا

“And they remained in their cave for three hundred years and exceeded by nine.”

(Surah al-Kahf, 25)

Indeed, 300 solar years equal exactly 309 lunar years due to the 11-day difference between the two calendars — a calculation that was not in reach of the Arabs at the time of revelation.

### 9- The Wisdom Behind Lunar Months Shifting Across Solar Seasons

Since lunar months are shorter than solar ones by about 11 days, they gradually shift through all seasons.

Fasting may occur in scorching summer, then years later in the cold of winter. Hajj may fall in the rainy season, and later in drought.

This ensures divine justice: no generation or region is exempt from hardship, nor uniquely favored with ease.

It is also noteworthy that the full cycle of these shifts takes 33 years. Whoever worships Allah across this span will have fulfilled acts of devotion in all seasons, symbolizing the completion of servitude in every circumstance.

### 10- Between the Backbone and the Ribs – Modern Discovery and Qur'anic Precedence

Allah said :

فَلْيَنْظُرِ الْإِنْسَانُ مِمَّ خُلِقَ • خُلِقَ مِنْ مَّاءٍ دَافِقٍ • يَخْرُجُ مِنْ بَيْنِ الصُّلْبِ وَالتَّرَائِبِ

“So let man observe from what he was created. He was created from a fluid, ejected, emerging from between the backbone and the ribs

Science has uncovered that Primordial Germ Cells (PGCs) do not originate in the testes or ovaries, but rather in the yolk sac wall of the embryo. From there, they migrate to the intermediate region between the spinal column (şulb) and the front of the body (tarā'ib), forming the gonadal ridge, where they later differentiate into testes or ovaries.

Thus, the human seed originates precisely between the backbone and the ribs, in line with the Qur'an's wording.

Furthermore, male fluid proceeds from his şulb (backbone), and female fluid from her tarā'ib (pelvic region with ovaries) — conception requires the union of both.

The Qur'an also affirms:

إِنَّا خَلَقْنَا الْإِنْسَانَ مِنْ نُطْفَةٍ أَمْشَاجٍ نَبْتَلِيهِ

“Indeed, We created man from a mixed drop of fluids that We may test him.”

(Surah al-Insan, 2)

Offered when the sun reaches its zenith, at peak white light. Prayer at this time stimulates serotonin secretion, improving mood, focus, and productivity, and preventing lethargy.

A Harvard University (2009) study confirmed that contemplative activities such as prayer reduce anxiety and enhance overall mood.

### **Qiyam al-Layl (Night Prayer)**

One of the greatest times for hormonal and spiritual balance. It enhances melatonin and happiness-related hormones during darkness, fostering deep relaxation. Night prayer also stimulates theta brainwaves, improving spiritual awareness and connection with God.

### Facing the Ka'bah: Magnetic Alignment and Bioenergy

Evening prayers (Maghrib and 'Isha) enhance theta waves, linked to deep relaxation and spirituality. Prayer reduces excessive beta waves, lowering stress and anxiety.

A University of Pennsylvania (2014) study showed that prayer improves cognitive performance and psychological well-being.

### Impact on Circulation

Fajr: Activates the cardiovascular system, energizing the body.

Dhuhr & 'Asr: Prevent mid-day sluggishness, reducing risk of blood clots.

Maghrib & 'Isha: Relax blood vessels, aiding restful sleep. Reducing Stress and Regulating the Nervous System

Prayer activates the parasympathetic nervous system (PNS), responsible for deep relaxation, thereby reducing cortisol — the stress hormone.

A Harvard Medical School (2009) study found that meditative practices like prayer reduce anxiety and improve mood. A study in the Journal of Applied Neuroscience (2016) showed that prostration increases blood flow to the pineal gland, enhancing melatonin release and regulating sleep-wake cycles.

The unique posture of sujūd also mimics therapeutic techniques for redistributing cerebrospinal fluid, potentially helping prevent neurodegenerative diseases such as Alzheimer's and Parkinson's.

Prayer enhances immune response by lowering stress and boosting antibody production (Immunoglobulin A), reducing inflammation.

### Why does the exposed body — even if tightly clothed — stimulate the male brain?

Modern neuroscience shows that men are highly responsive to visual stimuli. When certain parts of a woman’s body are revealed — even under tight clothing — the male brain immediately activates in specific regions such as:

Amygdala: responsible for emotional reactions. Visual cortex: processes fine visual details. Nucleus accumbens: associated with arousal and reward.

Thus, the clearer the bodily details, the stronger the neurological response and the greater the desire.

Hence the Prophet ﷺ said:

Not because fragrance is prohibited, but because he ﷺ understood precisely what scent does in the male subconscious.

The khimār is not merely a headscarf but a comprehensive concept of intelligent modesty, achieving three main goals:

Reducing visual stimulation: by preventing the brain from analyzing bodily form. Granting dignity and gravity: so the woman is treated as a conscious individual, not just a beautiful body. Enforcing self-respect: sending a silent message — “Respect me for who I am, not for my body.” What Happens When These Standards Vanish?

Antibacterial & antiviral: inhibits growth of respiratory, digestive, and reproductive pathogens.

Anti-cancer properties: compounds like Costunolide slow tumor cell growth. Circulatory stimulant: enhances blood flow, improves fertility, treats ovarian cysts.

#### Medical explanation:

Tabayyug refers to blood congestion or surging. Medically, it resembles hypertension or polycythemia (excess red blood cells), conditions that can lead to headaches, clots, and strokes.

Hijamah and bloodletting are natural methods to reduce blood density and protect health.

## Usury: Between the Curse of History, the Prohibition of Heaven, and the Collapse of Nations



### A Real-Life Example: How Usury Destroys an Entire Society

Imagine a small town where people work in different professions: a farmer, a builder, a teacher, a doctor, and a merchant.

In this town, a bank lends money with interest. The merchant borrows to finance his trade, but he is forced to raise his prices to cover the interest.

The wealthy lenders grow richer without producing anything, while the poor sink deeper into poverty. Even those who never borrowed are affected: high prices, fewer jobs, rising taxes, and deteriorating public services. Eventually, the town collapses into debt, poverty, and crime—all because of one thing: usury, which shows no mercy, not even to the innocent.

This is not fiction. Entire nations in the modern era have suffered the same fate when usurious banks and the International Monetary Fund dominated their economies.

## Usury in Ancient Civilizations: A Curse Repeated Through Time

From the earliest ages, civilizations knew of usury. Some prohibited it, others imposed strict limits, while many exploited it for wealth and power.

### Babylonian Civilization (2000 BC):

Interest rates on agricultural loans reached 33% annually, reducing farmers to slaves of their creditors. The Code of Hammurabi introduced limits on usury, but failed to abolish it

### Ancient Greece:

Aristotle described usury as “the most corrupt form of money-making” because it generates money from money without real production.

Despite this, the Greeks practiced usury—though often only on foreigners, while citizens were protected from extreme rates.

### Ancient Rome:

Initially, usury was completely forbidden and punishable by death. Later, as the empire expanded, it was gradually permitted, leading to mass bankruptcies and enslavement of the poor.

Rome eventually collapsed into financial ruin by the 4th century CE under the weight of debt and compounding interest.

### The Jews and Usury: From Prohibition to Exploitation Divine Prohibition for the Children of Israel

In the Torah, clear texts forbid usury among Jews themselves:

"إذا أقرضت مالا لأحد من شعبي، فلا تكن له كالمرابي، ولا تفرض عليه فائدة."

### (Exodus 22:25)

"If you lend money to one of My people among you who is poor, you shall not be like a moneylender to him; you shall not charge him interest."

But throughout history, many Jews circumvented this prohibition by applying it only among themselves, while practicing usury freely with non-Jews. This allowed them to dominate Europe's financial systems during the Middle Ages.

### Jewish Control of Finance in Europe

With the Catholic Church prohibiting usury, Jews found an opportunity to monopolize lending, since they were not bound by Church law.

They lent to kings and nobles at high interest, gaining immense political and economic influence.

In the 12th century, King Richard I of England imposed heavy taxes on Jewish moneylenders, and by 1290, Jews were expelled from England due to popular anger. In France, they were expelled in 1306. In Spain, they were permanently expelled in 1492, after centuries of financial exploitation.

### **Usury and the Collapse of the Modern**

Financial System Bretton Woods Agreement (1944):

After World War II, world powers agreed to peg global currencies to the US dollar instead of gold.

This gave the US the power to issue unlimited dollars and lend them at interest—especially to poorer nations.

In 1971, President Richard Nixon abolished the gold standard altogether. The dollar became nothing more than paper, yet it remained the world's reserve currency—cementing the dominance of usurious banking.

### **The International Monetary Fund: A Mechanism of Financial Enslavement**

The IMF lends at high interest rates, but imposes harsh conditions, including: Devaluation of local currencies, weakening purchasing power. Privatization of vital sectors, eroding economic sovereignty. Reducing subsidies and social services, worsening poverty and unemployment.

### **The result:**

Over 60 countries have lost economic sovereignty due to IMF debt. Some spend 50% of their budgets just on debt service. Poverty levels rise even though loans were meant to “help” them.

### **Why Did God Forbid Usury?**

The prohibition of usury is not merely a “religious law.” It is a divine safeguard for humanity against exploitation and economic collapse.

Economically: Usury destabilizes markets and triggers financial crises.

Socially: It widens the gap between rich and poor, enslaving the latter to creditors.

Psychologically: It breeds stress, depression, and even suicide under crushing debt.

Spiritually: God prohibited usury in all revealed religions and warned of its destruction.

**Ja'far al-Sadiq's Innocence from the Shi'a Creed**

“O Allah, be pleased with the two Shaykhs, Abu Bakr and 'Umar, for indeed they were Imams of guidance, and they were upon the truth.”

**(Narrated by Abu Nu'aym, Ibn Taymiyyah, al-Dhahabi, and others)**

He also said to those who claimed disassociation from them:

“Indeed I have in Abu Bakr an uncle, and in 'Umar a model to follow. Whoever disassociates from them is not of me.”

**(Reported by al-Tabarani and others)**

These are crystal-clear statements. How can we then believe that Imam al-Sadiq hated the Companions or founded a sect that curses them?

### A Victim of Politics, Not a Founder of a Sect

The so-called “Ja'fari Madhhab” of the Twelvers did not appear in his lifetime. It arose later, falsely attributed to him, and extremists ascribed to him fabricated reports, including:

Belief in his divine Imamate.

Claim of his infallibility and knowledge of the unseen.

Belief that the Qur'an is corrupted. Disassociation from the Companions.

**He was innocent of all these. He himself declared:**

“Whoever claims that we have knowledge of the unseen has lied about us. We are but servants who eat food and walk in the markets.”

And he openly disassociated himself from extremists like 'Abd Allah ibn Saba', saying:

“May Allah curse the one who says about us what we do not say about ourselves.”

### **His True Students Were the Imams of Ahl al-Sunnah**

It is not known that his earliest students were Shi'a in the modern sense. Rather, among those who studied under him were:

Imam Malik: "I never saw anyone more knowledgeable than Ja'far ibn Muhammad."

Imam Abu Hanifah: "If not for the two years, al-Nu'man would have perished."

Their schools of thought carried the legacy of al-Sadiq's knowledge. Hence, the similarities between them stem from the same wellspring.

If Imam al-Sadiq had held esoteric, hidden doctrines ascribed to him, these great Imams would not have learned from him nor praised him so highly.

### **Why Was His Knowledge Not Collected Like Others'?**

Political pressures: He lived under two oppressive regimes (Umayyad and Abbasid) and was constantly surveilled.

Forgeries: Extremists attributed to him reports he never uttered.

Lack of a formal school: He did not establish a madhhab nor appoint reliable students to codify his legacy.

After his passing, those who claimed loyalty to him splintered into numerous sects. Some declared his son Musa as Imam; others claimed occultation; some even deified him.

Ibn Khaldun: “All agreed on his nobility and leadership; he was among the chiefs of the ‘Tabi‘in.”

Thus, Ja‘far al-Sadiq belongs to the entire Ummah, not to one sect that monopolizes his name and distorts his teachings.

O you who love Imam al-Sadiq — listen to him, not to what is falsely ascribed to him. Take his religion, not the fabrications about him.

**He loved Abu Bakr and ‘Umar.**

### King Mu'awiyah or Sayyiduna Mu'awiyah?



A Human-Historical Reading of the Life of a Man Who Shook the Balance of the Caliphate – Without Sectarian Bias or Blind Fanaticism

### Introduction: Between Companionship and Power

There are figures in history who cannot be mentioned without controversy; hearts neither love them without reservation, nor reject them without shock.

Mu'awiyah ibn Abi Sufyan was a scribe of revelation and a Companion of the Prophet ﷺ, but he was also the first to break the precedent of the Rightly-Guided Caliphate, transforming the Imamate into hereditary kingship.

### So, should we call him: “Sayyiduna Mu'awiyah”?

### **The Cunning of Mu‘awiyah as Described by ‘Ali (RA)**

“By Allah, Mu‘awiyah is not more cunning than me, but he betrays and commits excesses. Were it not that I hate betrayal, I would be the most cunning of people.”

Here lies the difference between the cunning of nobility and the cunning of power.

### **The Shirt of ‘Uthman and the Guillotine of Politics**

After the assassination of ‘Uthman (RA), Mu‘awiyah carried the “Shirt of ‘Uthman” like a political banner—not to seek true justice, but to justify rebellion.

He did not avenge ‘Uthman once power was secured in his hands.

He refused to pledge allegiance to ‘Ali ibn Abi Talib, the legitimate Caliph, and fought him at Siffin, using arbitration as a weapon to dismantle legitimacy.

### **The result?**

The Ummah was torn apart. ‘Ali was assassinated through a Kharijite conspiracy.

Strangely, the Kharijites who troubled ‘Ali’s rule vanished entirely after his martyrdom. Mu‘awiyah and ‘Amr ibn al-‘As survived, harvesting the fruits.

**Al-Hasan al-Basri remarked:**

**“They fought against ‘Ali only for the sake of the world.”**

### **The Treaty with al-Hasan: Paving the Way for the End**

Al-Hasan ibn ‘Ali, the wellspring of Prophetic forbearance, accepted reconciliation with Mu‘awiyah to spare the Ummah from bloodshed.

**He said clearly:**

**“I only sought peace with Mu‘awiyah to prevent your slaughter.”**

### **He set conditions:**

No succession after him. No betrayal. No vengeance against Ahl al-Bayt or their supporters.

Yet once Mu‘awiyah consolidated power, he stood in Kufa and declared:

“By Allah, I did not fight you so that you might pray or fast... I fought you only to rule over you—and Allah has granted me that.”

It was the first moment the Caliphate was openly announced as coercive monarchy.

### **Al-Hasan Poisoned, Succession Planted**

Imam al-Hasan died by poison. Reports suggest that Mu‘awiyah—or his son Yazid, or one of their governors—bribed his wife Ja‘dah bint al-Ash‘ath with false promises, and she poisoned him.

### **Succession of Yazid: The Dawn of Authoritarian Rule**

Despite the treaty, Mu‘awiyah violated all agreements, imposing allegiance to his son Yazid by force of sword and wealth.

Al-Husayn ibn ‘Ali refused, proclaiming:

The martyrdom of al-Husayn and his family at Karbala.

Al-Hasan al-Basri: “Four men initiated the corruption of this matter: Mu‘awiyah, ‘Amr, al-Mughira, and Ziyad.”

Al-Dhahabi: “We love Mu‘awiyah, but we do not justify his mistakes.”

Al-Suyuti: “The first who changed the tradition of shura was Mu‘awiyah.”

Ibn Khaldun: “The rule of Mu‘awiyah was kingship, not Caliphate upon the Prophetic model.”

### **Conclusion: Between “Sayyiduna” and “Our King”**

Mu‘awiyah was not a devil—but he was not a rightly-guided Caliph either.

He was a shrewd politician who built a strong state—but upon the ruins of Prophetic spirit.

**He established modern governance—but legitimized betrayal, poison, and hereditary rule.**

**So should we say “Sayyiduna Mu‘awiyah”?**

Perhaps, if we mean his companionship with the Prophet ﷺ.

But if we seek justice, then we must tell the truth:

The Prophet ﷺ said:

«لا تقوم الساعة حتى يقاتل المسلمون اليهود ، فيقتلهم المسلمون ، حتى يختبئ اليهودي من وراء الحجر و الشجر ، فيقول الحجر أو الشجر : يا مسلم يا عبد الله هذا يهودي تعال فاقتله

“judgment day will not come until the Muslims fight the Jews, and the Muslims will kill them, until the Jew hides behind a stone or a tree, and the stone or the tree will say: ‘O Muslim, O servant of Allah, there is a Jew behind me — come and kill him.’” (Hadith — Arabic text as quoted)

Whenever I read the Prophet’s report about Muslims fighting the Jews, I always pause at that astonishing moment: the moment when stones and trees speak.

Why did that not happen in the Prophet’s own time, even though he fought some Jewish groups and besieged their strongholds? I used to wonder: what degree of corruption must the accursed ones attain before the earth itself becomes too narrow to hide them, so that inanimate things are roused to reveal their hiding places?

It became clear to me that the hadith is not describing a mere skirmish; it is describing a moment when tyranny reaches its utmost excess — a moment when the whole earth proclaims that such injustice is unbearable.

Today I am no longer asking — I am certain: this is our time.

What is happening now in Gaza — two years into what many call genocidal operations: children killed, homes razed, lands erased, even the sea crowded with their blood — intentional famine and the blocking of aid both near and far.

This is corruption beyond bearing: blood that cries out, mothers' lamentations filling the universe.

With an Arab, Islamic, and global abandonment, the corruption has reached such a degree that, were God to permit the inanimate to speak, it would.

We see with our own eyes the unfolding of this hadith; we live its opening episodes. It is the era in which creation sides with the truth — a warning from God that falsehood, however powerful, will find no shelter.

### ◆ A Warning to the Ummah:

**Silence is no longer permissible; neutrality is no longer an option.**

The battle over Gaza is not a local event — it is a major sign connected to the prophetic narration. (Jordan, Lebanon, Iraq, Syria, Sinai, Khaybar, the Gulf...)

Whoever does not learn a lesson today will find himself tomorrow at the heart of the calamity, when excuses and escape will avail nothing.

Either we stand with the front of truth, or the stones and trees will expose us on the day when God causes them to speak — as promised for the Hereafter.

## The Slaughter of al-‘Izzah and the Glad-Tidings of Near Victory

In an age of abundant betrayal, intense pain, and hearts filled with bewilderment, history bows before the patience of the people of Gaza — that small place God has chosen as a theater of martyrdom and a field that separates the camp of faith from the camp of hypocrisy.

But did the Messenger of Allah ﷺ ever indicate what is occurring in Gaza today? Are there prophetic reports that illuminate the path of the patient there and give them tidings of what is greater than this life?

The answer: yes — and in them are glad-tidings that soothe the breast and establish proof for wavering hearts.



### Ashkelon and Gaza: Twins on the Map of Prophecy

Before 1947, Gaza was considered part of Greater Ashkelon; therefore, what the hadiths mention about “Ashkelon” can be applied spiritually and practically to Gaza.

Imam al-Shāfi‘ī (may Allah have mercy on him) used to say, “I am from Ashkelon,” and sometimes, “I am from Gaza.” This geographical blending gives spiritual weight to the following prophetic narrations.

Prophetic Reports That Give Glad-Tidings to the People of Gaza 1.  
Uncounted Martyrs and the Bride of Paradise

**The Messenger of Allah ﷺ said:**

“Ashkelon is one of the two brides. From it on the Day of Resurrection will be raised seventy thousand who are not to be reckoned, and fifty thousand martyrs who will be delegations to Allah, and among them are ranks of martyrs whose heads are severed in their hands, their necks spurting blood. They will say: ‘Our Lord, give us what You promised through Your Messengers; indeed You never break Your promise.’ He will say: ‘My servants spoke the truth; wash them in the River of Al-Bayḍ (the White River), and they will come forth whiter than milk, and they will roam Paradise wherever they wish.’”

**(Narrated by al-Tabarānī and al-Daraqṭnī — Arabic sources as cited.)**

These are the people of Gaza today — their heads and limbs scattered, yet in the balance of heaven they are delegations to Allah: they are not to be questioned nor reckoned; rather it is said to them: “My servant has spoken the truth.”

## 2. The Cemetery of Ashkelon and a Great Intercession

Al-Daraqṭnī narrated:

“A cemetery in the land of the enemy called Ashkelon will be opened by people from my nation. From it Allah will raise seventy thousand martyrs who will intercede — a man will intercede for like Rabi‘ah and Mudar. For every bride there is a bride, and the bride of Paradise is Ashkelon.”

This is an incomparable honor: that a martyr from Gaza intercedes for an entire people. They are not mere victims; they are intercessors.

### 3. A Great Vigil and the Land of Resurrection

The Messenger ﷺ said:

“The best of the ribāṭs (frontier vigils) is the ribāṭ of Ashkelon.”

Saeed ibn Mansur related from ‘Awf ibn Mālīk:

“He said to me: ‘Advise me, O Messenger of Allah.’ He said: ‘Guard the mountain of Khamr.’ He said: ‘What is the mountain of Khamr?’ He said: ‘It is the land of the Resurrection.’”

Gaza lies on the outskirts of the land of resurrection — where the first raising will be, the first spreading, and the first stepping toward the Hereafter. It is the place of final selection.

### We Are in the “Second Corruption” of Israel, Backed by the Heraclius of Our Age — Trump

The Qur’an states:

وَقَضَيْنَا إِلَىٰ بَنِي إِسْرَائِيلَ فِي الْكِتَابِ لَتُفْسِدُنَّ فِي الْأَرْضِ مَرَّتَيْنِ وَلَتَعْلُنَّ عُلُوًّا كَبِيرًا

(Al-Isrā’ 17:4.)

“And We decreed for the Children of Israel in the Scripture that you will surely cause corruption on the earth twice and you will surely reach [great] haughtiness.” (Sahih International)

We are now in the phase of the second corruption and great arrogance, where the sons of Israel have gained control of the land and displayed corruption and oppression the likes of which were not seen, with direct political cover from the Heraclius of this age — Donald Trump — who granted them the most dangerous legitimizations (Jerusalem recognition, the Golan, normalization, the elimination of resistance, etc.).

They asked: “Where are they, O Messenger of Allah?” He replied: “In Bait al-Maqdis and the environs of Bait al-Maqdis.”

We have seen nations conspire, kin remain silent, and the world in disarray.

These signs are not defeat; rather, they indicate that victory is closer than the jugular vein: no victory without sifting, no empowerment without testing.

Some scholars have weakened these narrations, yet reality and the passage of time often corroborate certain prophetic statements.

These words are not metaphorical; they are an explicit call to annihilate entire peoples — words that are being retranslated today into every missile that falls on a Palestinian child.

### 2. 1 Samuel 15:2–3

“Thus says the LORD of hosts: ‘I will punish the Amalekites for what they did to Israel when they waylaid them on the way as they came up from Egypt. Now go and strike Amalek and devote to destruction all that they have. Do not spare them, but kill both man and woman, child and infant, ox and sheep, camel and donkey.’”

Killing children and infants? This is not a slip of the pen; it is a command that is enacted today before the eyes of the world.

### 3. Joshua 6:21

עברית (Hebrew Original):

וַיִּהְיוּ אֵת-כָּל-אֲשֶׁר בָּעִיר, מֵאִישׁ וְעַד-אִשָּׁה, מִנֶּעֶר וְעַד-זָקֵן, וְעַד שׁוֹר וְחִמּוֹר,

The pattern is the same: no distinction between child and elder, no mercy, no exception.

### The Talmud: Explicit Contempt for Non-Jews (as Quoted)

“The Gentiles (non-Jews) are not of the children of man.” — Talmud, Yebamoth 61a (quoted). “If a Gentile steals from a Jew it must be returned; if a Jew steals from a Gentile, he need not return it.” — Baba Kamma 113 (quoted).

An experiment at the University of California demonstrated that AI can analyze ultra-minute audio signals and translate them into written thoughts.

### ✓ **Behavioral data analysis and digital steering**

Companies such as Facebook, Google and Twitter deploy algorithms that monitor every interaction on your phone — from how long you pause on a particular image to posts you scroll past without clicking. These algorithms can infer your mental and emotional state and serve targeted content designed to nudge your opinions and behavior.

## **2. How are masses steered via technology?**

### 📌 **The Arab Spring: Mobilizing crowds via neuro-analytics**

During the 2011 uprisings, large-scale data analysis was used to gauge public sentiment and feed crowds with content intended to inflame anger or prompt specific actions. Wikileaks later revealed that Western companies developed psychological profiling tools for social media posts to read public moods and influence them.

### 📌 **The October 7 ambush in Gaza: digital deception**

Prior to the operation, there was an intensive misinformation campaign intended to create the illusion that Israel's situation was normal — reducing visible electronic military activity and encouraging Gaza fighters to move and breach borders. The objective, the article argues, was to create a pretext for a yearlong campaign to annihilate Gaza while framing the massacres as “self-defense” to the Western world. That is what has been publicly disclosed — it is almost certain that more advanced, undisclosed programs exist.

## 3. Why are these technologies used?

Control of public opinion: By feeding you content that matches your mood, your thoughts are guided without your conscious awareness.

Media deception and consciousness control: Data analytics reveal how to influence minds during crises. Security surveillance: Governments can profile and track people deemed potentially dangerous by analyzing their neural signatures and online behavior.

— [Al-Iklās]

(Sahih International): “Say, ‘He is Allah, [who is] One, Allah, the Eternal Refuge. He neither begets nor is born, Nor is there to Him any equivalent.’”

The Ra doctrine and the idea of a cosmic consciousness dissolve the Creator into the creation and claim that we are “God” or part of God — a clear form of shirk (associating partners with God).

#### ❖ Second: Prophethood and Revelation vs. Cosmic “Enlightenment”

In Islam, guidance reaches people by divine revelation delivered through Prophets. The philosophies of Ra, Hinduism, Taoism, and similar systems substitute revelation with “inner enlightenment,” “opening chakras,” or “accessing akashic records” — a manifest error.

Allah says:

وَمَنْ لَّمْ يَجْعَلِ اللَّهُ لَهُ نُورًا فَمَا لَهُ مِنْ نُّورٍ — [An-Nūr: 40]

(Sahih International): “And whoever Allah has not appointed a light for him — then for him there is no light.”

### ❖ Third: The Hereafter Is Real, Not an Illusion

Islam affirms the reality of Paradise and Hell, of accounting, scales, and resurrection. These doctrines promote reincarnation and karma as alternatives to divine judgment, denying the Resurrection.

Allah says:

أَفَحَسِبْتُمْ أَنَّمَا خَلَقْنَاكُمْ عَبَثًا وَأَنَّكُمْ إِلَيْنَا لَا تُرْجَعُونَ

— [Al-Mu'minūn: 115]

(Sahih International): “Then have you considered that perhaps you will be returned to nothing? And that you will not be returned to Us?”

### ❖ Fourth: The Dajjal and the Global System

The so-called Ra belief is part of intellectual preparation for accepting the Dajjal, who will appear as a “cosmic redeemer” offering false peace and demanding worship apart from God.

The Prophet ﷺ said:

«مَا بَيْنَ خَلْقِ آدَمَ إِلَى قِيَامِ السَّاعَةِ أَمْرٌ أَكْبَرُ مِنَ الدَّجَالِ»

(Hadith — Arabic text as cited in your original.)

“Between the creation of Adam and the Hour there is nothing greater than the Dajjal.”

The Ra doctrine is part of a Masonry-infused esoteric religion that seeks to expel God from hearts and minds under the name of “consciousness,” replacing the Qur’an with akashic records, the Prophet with the Dajjal, and Paradise with a deceptive karma.

The Prophet ﷺ also warned:

“Indeed in the Messenger of Allah you have an excellent example.” (Al-Aḥzāb 33:21).

— {وَمَا يَنْطِقُ عَنِ الْهَوَىٰ \* إِنْ هُوَ إِلَّا وَحْيٌ يُوحَىٰ}

[النجم: 3–4]

“Nor does he speak from [his own] inclination. It is not but a revelation revealed.” (An-Najm 53:3–4).

From the decisive Sunnah: the Prophet ﷺ said

, «...خَمْسُ صَلَوَاتٍ كُتِبْنَ عَلَى الْعِبَادِ» — (reported by al-Bukhārī).

“Five prayers were prescribed for the servants...” — (authentic hadith).

### Prayer and its scientific harmony with the biological clock

From a scientific perspective, prayer functions as a powerful organizer of the circadian rhythm. It contributes to:

Regulation of hormones. Stabilization of sleep–wake cycles. Stimulation of circulation and centers of concentration.

Fajr: activates the nervous system and prepares the day.

“And [mention] when Abraham was raising the foundations of the House...” (Al-Baqarah 2:127).

Scientific wonders associated with Makkah and the Ka‘bah (claims often cited)

These groups fuse ancient esotericism with modern intellectual trends and brand them as “true Islam.”

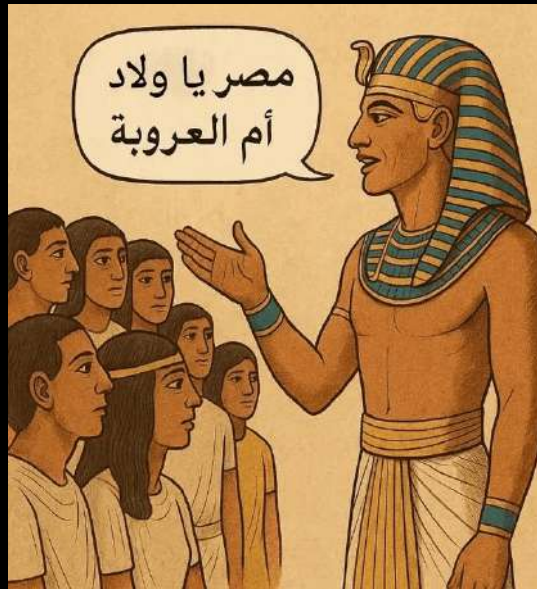
## **Conclusion: This Is Not a Mere Intellectual Dispute — It Is a War on Identity**

This explicitly states that the Temple was built on Mount Moriah, the place of the sacrifice, and that the Ark of the Covenant was placed there in the Holy of Holies.

### Who was the sacrificial son, and where was Mount Moriah?

#### 2. Ishmael Was the Sacrifice: Refuting the Torah's Narrative

While the Torah speaks of Isaac, the Qur'an clarifies through narrative sequence that the sacrificed son was Ishmael, not Isaac.

#### [الصافات: 101–107]

"So We gave him glad tidings of a forbearing boy. And when he was old enough to walk with him, he said: O my son! I have seen in a dream that I am sacrificing you. So see what you think... And We ransomed him with a mighty sacrifice."

#### [Surah As-Saffat: 101–107]

The name Moriah and the Meccan mount Al-Marwah are strikingly similar—both linguistically and spiritually. This suggests that the true site of sacrifice was in Mecca, not Jerusalem.

The Torah's alteration of the sacrificial son served a political agenda: transferring the center of holiness from Mecca to Jerusalem.

### 4. The Kaaba = The Temple: Parallels in Form and Function

1 Kings 6 describes the Temple:

"The house which King Solomon built for the LORD, its length was sixty cubits, its breadth twenty cubits, and its height thirty cubits... and he overlaid the house with pure gold."

The Kaaba is rectangular, draped in a gold-embroidered black covering, serving as the focal point of monotheistic worship.

Even the Jewish practice of the tefillin, black boxes bound and circled around the body, echoes the Kaaba's symbolism: a sacred cube as the axis of devotion.

Both the Kaaba and the Temple functioned as centers of worship for the One God.

### 5. The Ark of the Covenant and the Hidden Treasure

According to 1 Kings 8:6, the Ark was placed in the Holy of Holies beneath the Temple.

In Mecca, the Prophet Muhammad صلی اللہ علیہ وسلم said:

«...لولا أن قومك حديثو عهدٍ بجاهليةٍ، لأنفقتُ كنزَ الكعبةِ في سبيلِ اللهِ»

رواه البخاري –

"If it were not that your people have only recently left the ignorance of the past, I would have spent the treasure of the Kaaba in the cause of Allah..." – Narrated by Al-Bukhari

And he صلی اللہ علیہ وسلم said:

«اتركوا الحبشة ما تركوكم؛ فإنه لا يستخرج كنز الكعبة إلا ذو السويقتين من الحبشة»

رواه أبو داود –

"Leave the Abyssinians as long as they leave you alone, for none will extract the treasure of the Kaaba except the one with thin legs from Abyssinia." – Narrated by Abu Dawud

This "treasure" strongly suggests the Ark of the Covenant, hidden beneath the Kaaba—just as it had been beneath Solomon's Temple.

### 6. The Hoopoe: A Geographic and Scientific Clue

Allah says in Surah An-Naml:

“And he inspected the birds and said: Why do I not see the hoopoe? ... But it stayed not long, and it said: I have encompassed that which you have not encompassed, and I bring you sure tidings from Sheba.”

[Surah An-Naml: 20–22]

Scientifically, the hoopoe migrates thousands of kilometers using magnetic navigation. The quick departure and return described in the Qur'an makes more sense if Solomon's seat was in Mecca, closer to Sheba (Yemen), not in Palestine.

### 7. Solomon: King in Jerusalem, Builder in Mecca

There is no contradiction: Solomon could govern from Jerusalem while building his sacred Temple in Mecca.

The Bible affirms his enthronement in Jerusalem, but the Qur'an is silent on the Temple's location—leaving the matter open.

Would Solomon, who was granted dominion over all the earth, neglect the House of God in Mecca?

(لَخُلُقُ السَّمَاوَاتِ وَالْأَرْضِ أَكْبَرُ مِنْ خُلُقِ النَّاسِ وَلَكِنَّ أَكْثَرَ النَّاسِ لَا يَعْلَمُونَ)

(سورة غافر: 57)

The creation of the heavens and the earth is greater than the creation of “mankind, but most people do not know

(Qur'an, Ghāfir 40:57)

The reason for revelation, as reported, is that the Jews of Madinah used to speak about the Dajjāl and glorify his supposed miraculous powers. Thus the verse clarified: however great human knowledge becomes, it is nothing compared to the creation of Allah

## Parable Of The God's Light

This verse openly refers to the creation of mankind and their sciences—encompassing even attempts to engineer semi-conscious beings. This supports the view that the Antichrist (the Anti-Christ) may not be a .natural entity, but a highly advanced technological project

**And indeed, Allah is never unjust to His servants; He would not grant .a mere human supernatural powers to mislead them in their religion**

This project may well be tied to the Jewish messianic expectation of a “Messiah” who will rule the world

## Who is He

A hybrid human-AI entity capable of analyzing humanity’s data, predicting behavior, and simulating miracles through science — manipulating weather, .gravity, and energy

He may even have cracked the code of time, traveling across eras to steal knowledge and seduce mankind in every age — hence every prophet from .Noah warned against him, and Tamim al-Dari encountered him

## My personal opinion

he could be a future, hyper-advanced version of Elon Musk, Sam Altman, or Mark Zuckerberg — all pursuing immortality and dominion through .technology

## :According to abjad numerology

Elon Musk = 218

al-Masīḥ al-Dajjāl

218 = (المسيح الدجال)

Coincidence? I don't think

### ḥadīth: Universal Warning

النبي صلى الله عليه وسلم قال:

«مَا بَيْنَ خَلْقِ آدَمَ إِلَى قِيَامِ السَّاعَةِ أَمْرٌ أَكْبَرُ مِنَ الدَّجَالِ»

— رواه مسلم

From the creation of Adam until the Hour is established, there is no trial“ greater than that of the Antichrist (Dajjāl).”— Ṣaḥīḥ Muslim

### Why Does the Antichrist Melt at the Sight of Jesus

Prophetic narrations state that when Jesus descends, the Antichrist will .”“melt as salt dissolves in water

This does not sound like a normal biological reaction; rather, it aligns with the collapse of a technological system exposed to a specific energy or .frequency—possibly holographic projection

### The Antichrist (the Anti-Christ) may spread his presence .through holograms worldwide

Some ḥadīth describe him as one-eyed with an eye shining like a star. This could point to a cybernetic implant—an artificial, AI-enhanced eye with advanced computational capabilities

Such augmentation would enable influence over matter in ways incomprehensible to ordinary humans

### How Do We Resist This Trial

Cultivating awareness of AI and holographic technologies, so people are not deceived

Strengthening spiritual frequencies of faith, which may neutralize his systems

Rejecting blind awe at scientific “miracles” by applying critical, prophetic insight

### ḥadīth: Protection Through Sūrat al-Kahf

النبي صلى الله عليه وسلم قال:

### Basics of Tajwīd

(التجويد)

### Every Muslim Must Know



The Qur'an is the speech of Allah ﷺ, revealed to Prophet Muhammad ﷺ as light and guidance for all humanity.

Allah commanded us:

وَرَتِّلِ الْقُرْآنَ تَرْتِيلًا

wa-rattili al-qur'āna tartilā

(Al-Muzzammil: 4)

**“Recite the Qur'an in measured rhythmic tones.”**

The science of Tajwīd (التجويد) teaches us how to recite the Qur'an exactly as it was revealed—without altering the letters or distorting the meanings.

Learning Tajwīd is a communal obligation (farḍ kifāyah) in terms of teaching and spreading it.

But it becomes an individual obligation (farḍ 'ayn) when reciting the Qur'an, so that every Muslim reads correctly without major errors (lahn jalī) that change the meaning

## Parable Of The God's Light

### 1. Articulation Points of Letters (Makharij al-Huruf)

The makhraj of a letter is the place from which its sound emerges when pronounced.

They are divided into five main categories:

#### Al-Jawf (الجوف)

The letters of elongation (ḥurūf al-madd):

ا (alif), و (wāw), ي (yā').

They come from the empty space of the throat and mouth, relying only on airflow.

#### Al-Ḥalq- Throat – six letters:

Aqṣā al-ḥalq (deep throat):

ء (hamzah), هـ (hā')

Wasaṭ al-ḥalq (middle throat): ع ('ayn), ح (ḥā')

Adnā al-ḥalq (near throat):

غ (ghayn), خ (khā')

#### Al-Lisān (اللسان – the tongue) – 18 letters:

Back of the tongue:

ق (qāf), ك (kāf)

Middle of the tongue:

ج (jīm), ش (shīn), ي (yā' non-madd)

Tip of the tongue:

ص (ṣād), س (sīn), ز (zāy), ت (tā'), د (dāl), ط (ṭā') etc.

#### Ash-Shafatan (الشفتان – the lips)

Closing both lips:

ب (bā'), م (mīm), و (wāw non-madd)

Lower lip touching upper teeth: ف (fā')

## Parable Of The God's Light

### Al-Khayšūm (الخيشوم – the nasal cavity)

Source of ghunnah (nasalization), always with ن (nūn) and م (mīm) when doubled.

### 2. Al-Qalqalah (القلقلة – echoing sound)

It is the shaking of sound when pronouncing one of the qalqalah letters in a state of sukoon, making it strong and clear without exaggeration.

Letters: 5 –

ق (qāf), ط (ṭā'), ب (bā'), ج (jīm), د (dāl) –

summarized in

“قطب جد” (Qtb Jd).

#### Levels:

Minor (ṣuġhrā):

when in the middle of a word, e.g., يَبْغُونُ (yabghūna).

Medium (wusṭā): at the end of a word, unshaddah, e.g., الْبَرُّ (al-barr).

Major (kubrā): at the end, with shaddah, e.g., الْحَقُّ (al-ḥaqq).

### 3. Tafkhīm and Tarqīq (التفخيم والترقيق)

Tafkhīm (heaviness): sound is thick and fills the mouth.

Tarqīq (lightness): sound is thin and soft.

**Always heavy (mufakhkham):** the 7 isti'la' letters –

خ، ص، ض، غ، ط، ق، ظ

(kh, ṣ, ḍ, gh, ṭ, q, ḏ) – remembered by

“خص ضغط قظ”.

## Parable Of The God's Light

**Always light (muraqqaq): all other letters.**

Conditional letters:

ر (rā’):

Heavy if with fatḥah or ḍammah: رَزَقُوا (ruziqū).

Light if with kasrah: رِزْقًا (rizqan).

If sukoon, depends on preceding vowel: fatḥah/ḍammah → heavy (الْقَدْرُ – يُسْرُ),

kasrah → light (فِرْعَوْنُ), unless followed by isti‘lā’ letter (مُرْصَادُ).

**Lām of Allah (لفظ الجلالة الله):**

Heavy if preceded by fatḥah/ḍammah: قَالَ اللهُ – نَصْرُ اللهُ.

Light if preceded by kasrah: بِسْمِ اللهِ

### 4. Rules of Madd (أحكام المدود)

Madd = prolongation of sound in ا، و، ي (alif, wāw, yā’).

**Natural Madd (ṭabī‘ī):**

2 counts. e.g., قَالَ – فِي – نوح.

**Mandatory Joined Madd (wājib muttaṣil):**

madd + hamzah in same word.

4–6 counts. e.g., السَّمَاءُ – جَاءَ.

**Permissible Separated Madd (jā’iz munfaṣil):**

madd at end, hamzah at start of next word.

2–5 counts. e.g., إِنَّا أَنْزَلْنَاهُ.

## Parable Of The God's Light

**Necessary Madd (lāzim):** madd followed by permanent sukoon.

6 counts. e.g., الضَّالِّينَ – آلَانِ.

**Accidental Madd (‘ārid lil-sukūn):**

if stopping on a moving letter.

2–6 counts. e.g., العالمينَ – الرحيمَ.

**Madd al-Badal:** hamzah before madd. 2 counts. e.g., آمنَ – إيمانَ.

**Madd aṣ-Ṣilah:** in hā’ ad-ḍamīr (هـ) when between two vowels.

e.g., بهِ – بهُ.

## 5. Rules of Nūn and Mīm (أحكام النون والميم)

**Nūn sākinah and tanwīn:**

Iẓhār (clear): if followed by throat letters (خ، غ، ح، ع، هـ، ء). e.g., منْ أهل.

**Idghām (merging):**

With ghunnah: if followed by

(ي – ن – م – و) (Y,n,m,w)

2 counts.

Without ghunnah: if followed by (ل – ر). (L,R)

**Iqlāb (conversion):**

turn into م if followed by ب. B

e.g., من بعد → مِم بعد.

**Ikhfā’ (concealment):**

with 15 letters, e.g., منكم.

**Mīm sākinah:**

Iẓhār shafawī (clear): before all except م and ب. B

e.g., هم فيها.

**Idghām shafawī (merge):** before م. e.g., لكم ما.

## Parable Of The God's Light

**Ikhfā' shafawī (concealment):** before ب. e.g., يَرْمِيهِمْ بِحِجَارَةٍ.

**Nūn and Mīm mushaddadah (doubled):**

always pronounced with ghunnah, 2 counts.

## Conclusion

Tajwīd is not optional; it is essential for every Muslim to recite the Qur'an correctly.

Mastery comes not only through theoretical memorization

But by: Listening repeatedly to expert reciters (al-Ḥuṣarī, al-Minshāwī, 'Abd al-Bāsiṭ, etc.).

Learning directly from a qualified teacher. Practicing daily until tajwīd becomes natural in recitation.

◆ **Conclusion** ◆

All praise is due to Allah, by whose grace good deeds are completed. After a journey through the verses of the Written Book and the signs of the Visible Universe, it becomes clear that the Light is one, and that Truth never fades, no matter how many paths diverge.
